### Limousine Rules & Regulations

- Driver has the right to inspect any and all bags and backpacks for alcohol, illegal drugs and tobacco products.
- Itinerary needs to be presented to A1A Limo prior to the reservation date.
- The adult purchasing the contract or the contact parent must approve any changes in the itinerary after departure. Driver will contact parent or purchaser if passengers request a change.
- NO SMOKING inside the limo, No alcohol consumed by anyone! No illegal drug use of any kind. NO Exceptions!
- Clean up for spills, vomit, or any stains that will require interior detailing along with any damages sustained to the vehicle will result in a \$150 clean up fee plus additional costs of damage equipment.
- All unruly person(s) will result in all parties being dropped off at pick up location at the sole discretion of the driver (no refund given)
- We will not be responsible for any lost, damaged, or stolen property.
- Passengers in excess of the contracted number will be accommodated up to the vehicle's legal capacity. Under no circumstances will passengers in excess of the legal limit be transported.
- Termination of this contract will occur in the event of ANY Violation or breach of contract.
- This form needs to be signed by purchasing adult, contact parent, and students, and needs to be returned along with the reservation deposits.
